
Sir,

As per the resolutions of the meetings of the Executive Council of the University of Burdwan, held on 24/10/2017 [Item no. 184, under Any Other Matter], I am directed to inform you that the university authority has been pleased to permit Gitanjali College of Physical Education for introducing M.P.Ed. Course of Studies on and from the academic session 2017-19 subject to the fulfilment of the following terms and conditions:

1. The Governing Body of the college is to be constituted as per provisions of the University. Adequate fund for further development as well as maintenance of the college is to be provided by the organizing Committee of the college.
2. To start with the total intake of **40** students (One Basic Units) .
3. The Course Fee is Rs.**60,000/-** per annum including University Examination Fee Rs.**1,000/-**. Total course fee for 2 years is Rs.**1,20,000/-** per student.
4. The same Inspecting Team of the University shall visit the Gitanjali College of Physical Education, Village - Daikota, P.O.- Deriapur, Dist.- Birbhum, Pin- 731234 within 3 months from the date of commencement of classes.
5. The College authority shall abide by the Acts, Statutes etc of the University of Burdwan as are in force or as may be amended from time to time.
6. Teaching Staff is to be appointed with the approval of the selection Committee in which one expert is to be nominated by the Hon'ble Vice Chancellor on the said selection committee and the qualification of the teachers and the Principal will be as per the norms of NCTE and the university.

7. The college library is to be more equipped with syllabus oriented and reference books for which at least Rs 01 lakh only is to be allotted from the college fund .
8. The same will be specified by the university authority as per the extant rules and norms of the university.
9. Sufficient class rooms including smart class rooms for the proposed course are to be provided.
10. The college authority will arrange for sufficient number of classes for P.G. students for covering the syllabus at par with the university.
11. The university will not bear any financial implication in future because of this permission / affiliation.
12. Every year inspecting team of the university will visit the college.
13. Entire Admission process including selection will be done by the office of the undersigned.
14. Student and Teacher ratio will be as per the norms of the University.

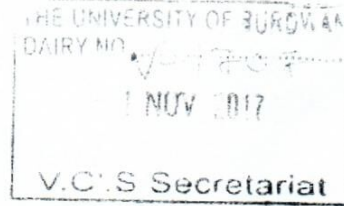
